Terms & Conditions

1. Deposit, Payment of Purchase Price, Fees

The buyer has paid a deposit to reserve the puppy. The buyer will pay the remaining amount of the puppy up to the release of the dog to the buyer. The expected pickup date is when parties agree upon it. Payment of the balance may be made by **Cash, PayPal, Venmo, or money order**.

Buyer acknowledges and agrees that buyer will forfeit the deposit and any rights to the dog if:

- Buyer fails to complete the purchase of the dog for any reason
- Buyer fails to pay the balance of the purchase price on or before the agreed-upon delivery date.

In either event, the seller shall be free to sell the dog to another party.

In the unforeseen event that the dog is not available due to sickness, death, or other circumstance of the seller's fault, the buyer's deposit will, at the buyer's option either be refunded or forwarded to the next litter.

2. Transfer of Ownership or Registration

- Upon payment in full of the purchase price, the seller shall promptly take all actions necessary to transfer ownership of the dog to the buyer.
- The buyer agrees to provide adequate food, shelter, and care for the puppy for its entire LIFETIME. The buyer also understands that routine care and veterinary care will be costly and is able to meet these requirements. The seller is not responsible for veterinary care and expenses that may arise once the dog leaves the custody of the seller.
- The buyer agrees that he/she is acting as or is part of any representative in the purchase of this puppy and that the

buyer will not sell the puppy or any of its offspring to any representative, laboratory, animal broker or pet store, or breeder. These are family pets, not breeding dogs. Puppies are sold with limited registration unless discussed prior to sale. The seller cannot in any way guarantee size, color, ear set, or coat type at maturity. the seller does not guarantee the ability of the puppy to show.

- If the buyer must ever surrender the dog to a shelter for whatever reason, at any age the dog MUST be returned to the seller. Arrangements and costs of transportation are the responsibility of the buyer.

3. Health Guarantee

- To the best of the seller's knowledge, this puppy was in good health and free from symptoms of contagious or infectious disease at the time of sale. The puppy was vet checked by the seller's veterinarian before the sale and a health certificate was obtained from a licensed veterinarian. The dog is purebred. Pedigree is correct and given at the time of pickup. The dog is registerable with the AKC.
- Dog will be free of hereditary crippling defects visible by 12 months of age. If the puppy has a LIFE-THREATENING congenital hereditary defect that has been diagnosed or examined by 2 unassociated veterinarians to seriously impact the quality of life or warrant euthanasia. Proof of diagnosis by a licensed unbiased vet and diagnosis paperwork must be submitted to the seller within 7 days of diagnosis. The seller also has the right to another opinion from another vet. In this circumstance upon diagnosis, the buyer must return the puppy to the seller and the seller will provide the buyer with a new puppy with similar traits, upon availability.
- The seller is not responsible for miscellaneous problems that can be preventable such as hypoglycemia, coccidiosis, giardia, parasites, types of bacterial infections, and certain disorders that may be caused by environmental factors such

as allergies, thyroid function, mange, and other autoimmune disorders. Vaccine injuries or reactions will not be covered. Hernia repairs or retained testicles do not warrant the return of monies they are not life-threatening.

- Seller is bound only to the original buyer, no warranties, either expressed or implied are made under this contract except as stated above. The buyer agrees to these terms and guarantees simply by the act of accepting the puppy, even if the contract is not signed or returned. The deposit is a promise by the buyer to buy the puppy named above and a promise by the seller to hold the puppy for the buyer until lit is old enough to be sent. **The deposit is non-refundable in the event the buyer changes their mind!!!!**
- We offer lifelong support for each puppy we place and there is no question or concern not important enough for us to answer. We take pride in our puppies and hope to build a relationship with you so we can see them as they grow up.
